Subject: 2022 Conservation Area User Fees

Recommendation:

THAT the proposed 2022 Conservation Area user fees be approved and become effective as of January 1, 2022.

Summary:

Grand River Conservation Authority Conservation Areas are intended to operate on a break-even basis. As a result, user fees are set to generate sufficient revenue to offset forecast expenditures for the upcoming year, and to support capital projects and infrastructure needs. This report outlines the proposed conservation area user fees for the 2022 season. The changes proposed include:

- Increase seasonal camping fees by 3%
- Some seasonal camping sites increased by 5% per annum to assist with gradual price realignment (i.e. premium sites, waterfront sites, sites undervalued in comparison to other GRCA sites)
- Increase nightly camping fees by 1.5%-2.5% (\$1.00)
- Increase day use fee by 3% (\$0.25)
- Increase Membership fees by 4%, (\$5 per annum)
- Membership passes provided to local libraries for signing out, costs supported by the Grand River Conservation Foundation – 2nd year of pilot program

Report:

The Grand River Conservation Authority (GRCA) operates eleven fee for use conservation areas and a wildlife management area. The Conservation Area program is intended to operate on a break even basis. User fees are determined through an analysis of estimated sales volumes for each revenue stream, with fees adjusted as necessary to cover forecast expenditures for the following year. Conservation Area fees are reviewed on an annual basis and fee changes are approved by the General Membership.

Actual visitation numbers are challenging to quantify in 2021. Conservation Area operations adapted to the pandemic, with a slow and cautious approach while maintaining capacity limits for both day use and camping throughout the season. Similar to 2020; pools and splash pads remained closed, canoe and kayak rentals did not open, and food concessions either did not operate or were provided by third parties. In 2021 the Elora Quarry was opened with limited capacity and with a ticket reservation system, which was a great success. We continued to integrate new technology to provide contact free ways for our visitors to provide payment. An e- pass parking Quick Reference (QR) code system was developed in-house to capture day visitors and membership holders who visited the conservation areas when gate staff are not present, mostly September through May, mid week type of activity where a full time gate attendant is not cost-effective. Membership sales

continued to be popular throughout the season, with over 9500 memberships purchased or renewed as of September 2021.

Capacity limits in Conservation Areas were met on many days throughout the season, and in July, a plan was developed to re-assess capacity at 4:30pm each day to determine any available capacity for the remainder of the day. This re-evaluation had a positive impact for local customers who wished to enjoy an evening walk or swim, after the peak capacity period passed.

Conservation Areas met the budget target of 7.2 million and are trending to end the year at 9.5 million while maintaining our capacity maximums. In part due to travel restrictions and increased local usage. It is impossible to predict what 2022 will bring with respect to visitation estimates.

In 2022, Conservation Areas are planning to continue to operate with visitor capacity maximums set at a level to ensure compliance with potential limits on use imposed by external agencies and various levels of government (public health orders, reopening stages etc.). It is forecasted that the Conservation Areas will continue to be popular for outdoor recreation and that instituting capacity limits on site users and restrictions on targeted activities (like camping or facility rentals), will likely be required.

Any surplus revenue is placed into a stabilization fund for conservation areas that funds capital projects and helps to offset any shortfalls in revenue in years of inclement weather or other operational impacts.

Admission Fees

Day Use Admission Fees

In 2022, day use admission fees are proposed to have a slight increase to mirror the rise in inflation and costs associated with operating conservation areas. GRCA is committed to providing a space where people to connect with nature. Fees will be posted as \$6.86 plus tax, for a total of \$7.75.

Membership

Local residents who utilize the conservation areas on a regular basis can make use of the Grand River park membership pass, which will also have a slight increase of 4% or \$5 and \$4 respectively, in 2021. A membership pass will cost \$145 and \$124 for seniors which represents the cost of approximately 6 visits for a family of four or 9 visits for a senior couple.

Memberships are valid for one year from the date of activation and allow entry to 10 conservation areas (excluding Elora Quarry) and Luther Marsh Wildlife Management Area, for up to 6 people per visit.

In spring of 2021 a pilot program that offered membership passes to all of the municipal libraries throughout GRCAs watershed was funded from a donation from the Toyota Manufacturing Corp and through the Grand River Conservation Foundation. This program enabled public library users to sign out a membership pass for a predetermined period and use it to enter the conservation areas. This is part of the initiative of GRCA strategic plan to connect our watershed residents with nature. The program is entering the second year of the pilot project in 2022 and we will be tracking use from the local libraries to understand the interest of local patrons. Many libraries have purchased "extra" memberships, in addition to the donated membership pass, as the program is so popular.

Elora Quarry:

In 2021 a new reservation system was developed, implemented, and supported by in house staff at the Quarry in order to manage capacity, to reduce impact to the site, to reduce impacts of vehicle lineups on municipal roads, to support efforts to curb parking at other businesses in the community, (combined with the new perimeter fence to work to define trespass), and to reduce reliance on paid off duty OPP officers for support with traffic management and trespassing issues. The reservation system allowed for 200 people in two, four hour blocks per day (morning and afternoon). By managing the numbers, feedback indicated that the customer experience was greatly improved.

A separate and incremental fee was also set for parking. The number of parking spaces are controlled, ensuring that access to the Conservation Area for EMS would always be available. The changes that were implemented proved successful. Elora Quarry staff received compliments from neighbours and the OPP regarding the new system. Customers indicated that they appreciated the increased space on the beach that was physically distanced. In addition, staff felt that they were better able to support those who were visiting and could provide excellent customer service.

Boat Launch Admission

The GRCA provides boat launch facilities at both Belwood Lake and Conestogo Lake. These two reservoirs offer the largest bodies of water suitable for power boating without traveling to either one of the great lakes or Lake Simcoe. As a result, they are exceptionally popular with the boating

community. 2020 and 2021 saw an increase in users at the boat launches, especially mid-week. The GRCA charges a separate fee, in addition to park admission, to use the boat launch, which has been set for many years at \$9. The fee was increased in 2020, to \$11.50 and in 2021 and proposed to increase to \$12.50 (including tax). This increase is to assist with bringing the fee into realistic alignment with other boat launches throughout the province. Season pass launch permits are available at Belwood Lake and Conestogo Lake for \$100.00 per season, in addition to a membership pass.

Camping Fees

a) Nightly Camping Fees

To offset expenses related to campground operations and in keeping with local competitors an increase to nightly camping fees is recommended (see Appendix A). In 2020, GRCA operated the campgrounds at around the 50% maximum occupancy mark to allow for physical distancing. In 2021, we started out at 50% occupancy, increasing to 75/80% in August as sites and facilities allowed for appropriate physical distancing, and as allowed under the provincial COVID-19 restrictions. 50 new overnight sites at Elora opened in July of 2021, and were very popular all season.

b) Seasonal Camping Fees

The seasonal camping program continues to be popular with all conservation areas experiencing full occupancy of seasonal campsites. The lottery program for allotment of open seasonal camping spots (sites that were vacated after the previous season) is in its fourth year and has been working well.

Seasonal camping fees are proposed to increase by 3%. The proposed fees are shown in Appendix B. The annual fee adjustment also helps to offset fixed cost rate increases such as insurance any hydro costs, which are increasing both because of utility pricing and due to larger camping equipment with greater power requirements.

Seasonal sites with full hook-up (hydro, water and septic) at Brant and Elora Gorge conservation areas are seeing a 5% increase. Waterfront premium seasonal campsites are also increasing by 5%. Seasonal Campsites at Conestogo Lake are also increasing by 5% to better align pricing with other GRCA seasonal camping sites that offer similar attributed sites. This gradual realignment is more realistic of the service/amenity provided and is comparable to our competitors.

Seasonal campers may also purchase a second season pass and the proposed rate is \$90 in 2021. The maximum number to be purchased at a discount is 2 per seasonal campsite.

c) Additional Vehicle Permit

The GRCA allows campers to purchase a permit for an additional vehicle that can be assigned to a campsite and remain in the Conservation Area overnight. The proposed fee is that of \$16.95 after tax per night, in alignment with the auto gates.

GRCA campground rules permit a maximum of two vehicles to be parked on a single campsite with the exception of Rockwood, which is one vehicle per site. Any vehicles in excess of this must be parked off the campsite in nearby parking lots. This fee increase may encourage car-pooling and the reduction of extra vehicles in the campground.

Fee Rate Comparison

Accompanying this report are comparison statistics from Ontario Parks, other Conservation Authorities, and private campground operators. Each year the GRCA compares proposed conservation area fees against competitor's fees to ensure that the proposed fee structure is in line with the rates charged by operators of similar facilities and services. The rate comparisons for day use admissions are shown in Appendix J. The comparators for nightly camping are shown in Appendix K and the comparators for seasonal camping are shown in Appendix L Fee rates for 2022 are not yet available for most competitors. As a result, the comparator tables show a mix of annual fees. The proposed 2022 fees generally fall in the middle of the range of fees for GRCA's competitors.

Hunting Fees

Hunting is offered within designated zones at Belwood Lake, Conestogo Lake, Luther Marsh Wildlife Management Area and at 17 miscellaneous properties throughout the central and northern portions of the watershed. In order of obtain a GRCA hunting permit a hunter must be a member of the Ontario Federation of Anglers and Hunters and possess the appropriate provincial and/or federal hunting license(s) and stamps and/or tags. The GRCA hunting permit must be displayed in the windshield when hunting on GRCA properties. The fees for the various classes of hunting permits offered by the GRCA are a shown in Table 3 below.

Financial implications:

The Conservation Areas operate on a not-for-profit basis and the revenues generated by the proposed 2022 user fees are sufficient to meet the forecast expenditures assuming an average year of visitor attendance, suitable weather and planned capital expenditures. Revenue surpluses are placed in a reserve fund and may be used to augment revenues if lower than expected visitation occurs or if expenses exceed projections. There are operating budget efficiencies that are attained as a result of the integration of the Conservation Area program with other program areas such as water management, nature centres and property. The operating budget does not include the application of overhead administrative support from senior management, accounting, payroll, human resources, and communications.
