- On January 8th, staff received notification that the Minister of Natural Resources has approved GRCA's request to use the land sale reserve to assist with managing the estimated budget shortfall in the new Guelph Lake Nature Centre construction project.
- The Ministry of Natural Resources is implementing its legislated ability to appoint a
 representative of the Agricultural sector to a number of Conservation Authority Boards, including
 Grand River. The position is currently posted on the Ministry's website and is open to members
 of the agricultural community but excludes any person who is already municipally appointed to a
 Conservation Authority Board. The Chair noted a letter would be sent to the Ministry regarding
 this position.
- Staff have been presenting the draft budget to participating municipal councils when requested, and over the past month have presented to Brant County, the City of Guelph, and the Township of Wellington-North. Samantha Lawson and Joel Doherty also attended the Township of Puslinch council to present the Conservation Area Strategy and Land Inventory.
